## The Hannibal Country Club Membership Options

~~Initiation Fee—\$1,500~~ – **Waived for 2018!**  
Stock Purchase one (1) share of stock for \$100.

### General Memberships

Single Membership- \$1,833 per year, minimum monthly food charge of \$30 and monthly debt reduction/capital improvement of \$25\*.

Family Membership - \$2,613 per year, minimum monthly food charge of \$60 and monthly debt reduction/capital improvement of \$35\*.

### Senior Memberships – 75 years of age or older

Senior Single Membership – \$1,435 per year, minimum monthly food charge of \$30 and monthly debt reduction/capital improvement of \$25\*.

Senior Family Membership - \$1,949 per year, minimum monthly food charge of \$60 and monthly debt reduction/capital improvement of \$35\*.

### Junior Membership – Until Age 40

Single – \$939, minimum monthly food charge of \$30 and monthly debt reduction/capital improvement of \$25\*.

Family Membership – \$1,253 with minimum monthly food charge of \$60 and monthly debt reduction/capital improvement of \$55\*.

### Non-resident Membership – Over 60 mile radius from HCC

Single Membership – \$939 per year and monthly debt reduction/capital improvement of \$25\*.

Family Membership - \$1,253 and monthly debt reduction/capital improvement of \$35\*.

No initiation fee or monthly food minimum. Non stockholder & non-voting member.

### Lockers (Gentlemen's & Ladies) – *Optional*

- Full Locker - \$40 Per Year.
- Half Locker - \$25 Per Year.
- Liquor Locker - \$15 Per Year.
- Golf Bag Storage - \$30 Per Year.

*\*Such fees shall be held and accounted for separately from other monies due the club and used for the sole purpose of retiring any debt owed by the Club or emergency improvement situations. Should the club have no debt, the monies collected under this section shall be used for the sole purpose of capital improvement for the Club. A Minimum will not be billed for the month of January. A Family Membership includes Singles with significant others.*



## Corporate Memberships

**Gold Corporate Membership** (10+ Employees) \$4,914 per year with 3 core members who receive voting rights, minimum monthly food charge of \$60/month per core member, \$35 per month per core member capital assessment – full access to the club.

**Sterling Corporate Membership** (-10 Employees) \$3,276 per year with 2 core members who receive voting rights, minimum monthly food charge of \$60 per core member, \$35 per core member capital assessment – full access to the club.

**Corporate Associate Memberships** - Associates (employees or partners) of Sterling or Gold corporate members can be members of the club for only \$852 per year. Capital fees of \$35 per month per associate apply. Associate members have a monthly food minimum of \$60 and full access to the club.

## Trial Memberships

Trial memberships are available for those wishing to experience the social and recreational opportunities of the Hannibal Country Club. None of the trial memberships have initiation fees, stock purchase, or voting rights. All trial memberships are considered temporary and may change or discontinue after the end of 2018. Non-members for the last 12 months or longer are eligible for the trial memberships. Trial Memberships will not be granted partial year fees. The full price will be charged regardless of when the member joins.

**Family** (includes significant others) – \$1306 plus \$60 monthly food and \$35 capital\*

**Single** – \$916 plus \$30 monthly food minimum and \$25 capital\*

**Senior Family** – \$974.50 plus \$60 monthly food minimum and \$35 capital\*

**Senior Single** – \$717 plus \$30 monthly food minimum and \$25 capital\*

**Junior Family** – \$626.50 plus \$60 monthly food minimum and \$35 capital\*

**Junior Single** – \$469.50 plus \$30 monthly food minimum and \$25 capital\*

**Non-Resident Family** – \$626.50 plus \$35 capital per month\*

**Non-Resident Single** – \$469.50 plus \$35 capital per month\*

**Corporate Large** \$2457.00 plus \$60 monthly food minimum and \$35 capital per member\*

**Corporate Small** \$1638.00 plus \$60 monthly food minimum and \$35 capital per member\*

**Corporate Associate** \$426.00 plus \$60 monthly food minimum and \$35 capital per member\*

## Special Memberships

**Two Month Trial Membership** (2 consecutive months) for those that have never been a member of the club. No food minimums, pay as you go. No voting privileges.

**New Family \$400 New Single \$250.**

**Roaring Twenties Membership** – Ages 21-29 who have never been a member of the club may join for a flat monthly fee. No food minimums, and you must pay as you go, no voting privileges.

**Twenties Family \$75 Twenties Single \$50**

**Golf Membership** – This membership does not allow clubhouse use except to get beverages, snacks or food for the course or patio. *Does include use of the Pro Shop.*

No food minimums, no voting privileges.

**Golf Family \$1000 Golf Couple \$750 Golf Single \$500**

**Pool membership** – \$250, pool use only with food and beverages purchases allowed from the club for the pool.

### **Member of another country club?**

Any member of another private country club within the area may join for *1/2 price of the normal fee* of the category membership and have full membership privileges. Monthly food minimums and capitals apply.

## Hannibal Country Club Billing Policy

**Dues Policy** - Yearly dues are billed and mailed on the first day of January. Invoices reflect dues for a full year. There are three payment options you may choose. The payment option chosen below will apply to yearly dues, assessments and initiation fees. The following are those options:

\_\_\_\_\_ **Option 1:** You may pay the invoice in full by January 31. If mid-year membership applies, dues may be pro-rated and paid in full upon acceptance.

\_\_\_\_\_ **Option 2:** You may pay half of your invoice by January 31. On April 1, a statement will then be mailed reflecting your outstanding balance to date and full payment will be due by April 30 (On April 1, a statement will be mailed with the amount of your final payment).

**Initiation Fee Policy** –A member billed for the one time initiation fee has three payments options.

\_\_\_\_\_ **Option 1:** The first option would be to pay in full upon acceptance.

**WAIVED FOR 2018!**

\_\_\_\_\_ **Option 2:** This allows for partial payment now and the remaining half to be paid next year.

\_\_\_\_\_ **Option 3:** If you and your spouse are both under the age of 40, option three would allow the full payment to be divided equally over five years.

### General Policies:

- If no activity such as a payment or letter of termination is received by January 31, a second invoice will be mailed. After the mailing, if a payment or letter is not received by February 28, names will be turned over to the board at the March meeting for personal contact.
- Should a member terminate membership mid-year, full dues, initiation and food assessments shall remain due and owing for the remainder of the year.
